UCB#1 HYBRID PISTACHIO SEED (*P. atlantica* x *P. integerrima*)

Deadline For Requests: November 15th

Distribution: End of November through Early January

UCB#1, a hybrid of *Pistacia atlantica* X *Pistacia integerrima*, was selected by Dr. Lee Ashworth of the UC Berkeley Department of Plant Pathology for its resistance to *Verticillium* wilt. Due to current short supplies, only those submitting orders by November 15th are likely to receive seed.

BUDWOOD OF UCB#1 PARENT TREES (*P. atlantica* female and *P. integerrima* male)

Deadline For Requests: June 1st

Distribution: Late June through September

Limited requests for budwood of parent trees will be accepted only upon execution of a grower agreement stipulating payment of user fees on trees, seed and any other asexually propagated unit from a seedling which is produced using the budwood.

Individual Budwood Stick \$50.00/budwood stick
(Supplied in approx. 6" cuttings of no less than 4 buds each)

Material Allocation Policy

Because FPS expects UCB#1 pistachio seed and parent budwood to remain in short supply over the next few years, the formal allocation systems detailed on the attached sheet have been established for seed and budwood requests. All requests for material from within the U.S. will be supplied before any foreign requests are considered. Requests for pistachio material must be received by the allocation deadline specified on the reverse for each type of material. Available material is allocated among all whose orders are received and confirmed before the deadlines noted. Orders are considered confirmed upon receipt of an original signed order form and the required prepayment. Orders received after the allocation deadlines will be supplied on a first come, first served basis, if material is still available.

Prices & Prepayment

No requests will be considered until an original signed Pistachio Material Order Form and 50% prepayment (payable to "UC Regents") are received. The minimum order charge is \$100.00 per order for budwood and \$25.00 per order for seed. Prices, prepayments and final billings are based on the number of units ordered. Prepayment in the amount of 50% of material cost is required for domestic orders at the time the order is placed; 100% prepayment in U.S. dollars is required for foreign orders. Prices are subject to change without notice.

Order Pickup/Shipping and Packing & Handling Charges

ALL MATERIALS ARE SHIPPED F.O.B. DAVIS, CALIFORNIA. BUYER AGREES TO PAY ALL COSTS OF TRANSPORTATION AND ASSUMES ALL RISK OF LOSS DURING SHIPMENT. No shipping or packing & handling fees are charged for orders picked up at the FPS facility, however, due to space and labor limitations, FPS asks that all orders for seed or budwood be picked up within 30 days of notification that they are ready for pickup. FPS reserves the right to assess customers for storage of materials not picked up after 30 days. For all orders that are shipped to customers, shipping fees are added to the price of the material along with any fees for required documentation, testing or foreign shipment. Shipping fees are charged at the actual cost to FPS.

Policy on Cancellations and Changes to Orders

Because FPS materials are custom collected and prepared for each customer, cancellations are not accepted once material has been collected. Exceptions are considered on a case-by-case basis at the discretion of distribution manager and production manager only if another buyer is available for the cancelled material. Additions to orders will receive allocation priority according to the date they were added. FPS reserves the right to bill for and/or retain prepayments for materials that are cancelled once they have been collected or prepared. Plant material may not be returned to FPS for credit or refund once the material has left the FPS facility.

Foreign Orders

All orders for shipment outside the U.S. are shipped by airfreight. 100% prepayment for plant material, documentation, treatment and estimated shipping costs is required on all orders going outside the U.S. Most foreign orders require an import permit from the destination country's national plant protection service in order to obtain the required phytosanitary certification.

Phytosanitary Documentation

Domestic customers will be charged at actual cost for any needed quarantine compliance certificates. Foreign customers will be charged \$50.00 for each federal phytosanitary certificate, as well as the cost of any special testing or treatments required by destination country.
